Step by step process

It may be mentioned that the Nagaland Building Byelaws, 2012 was first approved in 2012, to be enforced by the Urban Local Bodies of the State. However the Nagaland Building Byelaws, 2012 could not be enforced due to lack of Technically qualified manpower such as Architects and Engineers etc, in the ULBs, to study/examine the building Plans/Proposals and to take up prescribed procedures necessary for issuing Building Permits/Completion Certificates, etc. Only qualified Engineers and Architects are competent to take up such works.
